- Rent for office space / business premises
- Utility bills for business use
- Office supplies and equipment

#### 2) Travel Expenses:

- Mileage
- Parking fees
- Public transport costs for business travel

#### 3) Clothing Expenses:

- Uniforms
- Protective clothing
- Costumes for entertainers

#### 4) Staff Expenses:

- Salaries
- Bonuses
- Pension contributions


#### Importance of Record Keeping


